Contest Rules

Entry rules

The video must meet all Contest requirements to be eligible to win a prize: it must be 5 MB or smaller in size and contain the participant’s first and last name in the file name. Incomplete entries or the ones which are not in alignment with the rules, requirements, and specifications will be disqualified by **LatinPerDiem**. You may enter the Contest only once and you need to provide any information that might be necessary. Any attempt of circumvention of the rules will result in immediate disqualification from the Contest.
